With reference to the above-referred tender invited through e-Tendering mode for “**Supply & Installation of Meter Boxes, Distribution Box and allied accessories for Smart Metering Project at Chandigarh Electricity Department (CED)**”, RECPDCL will carry out the Reverse Auction as per the Clause no.2 of Section V (Special Conditions of Contract), among the technically qualified bidders as mentioned below on due date & time as hereunder:

EMD submitted against the NIT by the bidders is valid and RECPDCL will consider the same for the purpose of Reverse Auction. All other terms and conditions will remain the same.

The methodology to calculate item wise minimum rate from the quoted overall rate along with Reserve price, Decrement value, time duration & Incremental time are as follows:

1. Reserve/Ceiling price to be kept for conducting e-reverse auction is Rs. 5,72,34,837.97 /-.
2. The overall lowest price quoted by the bidder will be considered as L-1 bidder after completion of reverse auction. Further, the item wise price shall be arrived from the overall lowest quoted price in the same ratio as quoted by the bidder earlier in the financial bids opened on 11.11.2019.
3. Decrement value to be kept for conducting Reverse Auction is Rs. 12,00,000.00/-.
4. The time duration to be kept for conducting Reverse Auction process is from 10.30 AM to 1.30 PM with the incremental time duration of 30 minutes from the time of latest quote. The auction shall terminate at scheduled end time or as extended as per requirement till there is no response during the incremental time duration.
