OBJECTIVES

RECPDCL have entered an MOU with REC wherein one of the parameter is with respect to ISO certification. Accordingly, it is envisaged that RECPDCL will need the services of competent certification body to implement the requirements of ISO 14001:2004 certification. This Limited Tender has been developed to assist REC Power Distribution Company Ltd to select a competent firm.



SECTION-III SCOPE OF WORK

The firm may be engaged as certification body for ISO 14001:2004 for certification in respect of Official Work of corporate office, RECPDCL, New Delhi.

The certification body/firm shall carry out the certification/rectification audit and issue ISO 14001:2004 certificates after successful audit

TIMELINES

The Audit and Duration of completion shall be as under.

i	Certification of Audit & issue of certificate.	a) Stage I audit to be commenced within mutually agreed date b) Certificate to be issued by 28 th January 2015 after successful completion of Stage-I audit.
ii	Surveillance Audit-1	Within 11 months of stage-II audit.
iii	Surveillance Audit-2	Within 1 year of Surveillance Audit-1

- a) Certification body will have to carry out surveillance audits at regular intervals to maintain continuity of the certification within the prescribed duration for each audit within increase in charges whatsoever.
- b) Certification body shall carry out the audits on the mutually agreed dates within the time schedule.



SECTION-IV INSTRUCTIONS TO CONSULTANT

PRICE BASIS AND PAYMENTS

The proposal should include price all-inclusive lump sum (including travel and other out of pocket expenses, etc.) in Indian Rupees only, for the entire scope of work covered under the Terms of Reference on a FIRM price basis (with no escalation provision for whatever reason) valid till the complete execution of the assignment as per the format at **Annexure –A** in a separate envelope sealed properly. The Contract price and the scope of work also include any services, etc. which is not specifically identified but are required for completion of the assignment. Service Tax, if any, will be paid extra at the applicable rates and is not to be quoted above.

TERMS OF PAYMENT

All payments would be claimed by the Firm from RECPDCL on being due, and would be accepted for payment by Competent Authority of RECPDCL based on the satisfactory progress and quality of the work in sole discretion of RECPDCL. The payment to the Consulting Firm under the contract shall be released after achieving the milestones as per the following terms:

S.No	Milestones	Payment
1.	After submission of Certification of Audit & issue of certificate.	60% of Contract Value
2.	After Surveillance Audit-1	20% of Contract Value.
3.	After Surveillance Audit-2	20% of Contract Value.

The certification body shall raise invoice after the audit as per the charges quoted after successful completion of each audit for scrutiny and release of payment by RECPDCL.

TAXES AND DUTIES

RECPDCL shall be entitled to deduct applicable tax (if any) at source as per Indian Laws from all payments due to the Consulting Firm under the contract.

As regards the Indian Income Tax, surcharges on Income Tax and any other Corporate tax, RECPDCL shall not bear any tax liability, whatsoever, irrespective of the mode of contracting. The Consulting Firm shall be liable and responsible for payment of all such taxes, if attracted under the provisions of the law. In this connection, attention of Consulting Firm is invited to the provisions of Indian Income Tax Act and the circulars issued by the Central Board of Direct Taxes, Government of India.

OWNER'S RIGHT TO ACCEPT/ REJECT THE PROPOSAL

RECPDCL reserves the right to accept or reject the proposal at any time prior to award of Contract, without thereby incurring any liability to the Consulting Firm concerned or any obligation to inform the Consulting Firm concerned of the grounds for the Owner's action.

Sub-Contracting

Consulting firm to whom work is awarded are not allowed to sub contract the work to any other parties either in part or full.
